Eligible applicants must possess a completed Bachelor of Laws (LLB) degree. Final-year LLB students may apply, provided they complete their studies before the commencement of the program. Applicants must be unemployed, without any prior legal experience or participation in Practical Vocational Training for legal practitioners. South African citizenship is mandatory. Permanent employees of the Department of Justice and Constitutional Development (DOJ&CD) and the NPA who meet these criteria are also eligible to apply.

### Job Benefits

Participants of this program will gain invaluable experience and mentorship under the guidance of senior prosecutors. This training offers a unique opportunity to develop a profound understanding of legal procedures, thereby enhancing employability within the legal profession. Successful aspirants may be considered for permanent or contract positions as District Court Prosecutors, although placement is subject to the discretion of the NPA and may occur at any office nationwide.
